Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

The Board met with custodian Randy Norman and discussed regular courthouse maintenance.

The Board met with Engineer Ryan Schock and signed funding agreements for bridge projects BROS-SWAP-CO26 (100)-FE26 and BROS-SWAP-CO26 (109)-FE26 on Jade Avenue. Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to sign utility permit for Wapello Rural Water Association. Budget amendment #1 for FY20 was signed.
