The Davis County Board of Supervisors met in regular session on Monday, February 7, 2022, with Chairman Alan Yahnke and Members Ron Bride and Matt Greiner present.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

There were no comments made by the public.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Monday, January 31, 2022.

The Board met with custodian Randy Norman, and they discussed some dead trees in the courtyard that will need to be removed before the ground thaws this spring.

The Board met with Engineer Ryan Schock, who reported on the road blading, hauling rock, and cutting brush by the county crews this past week. He also reported that Cody Garmon will be taking over blade duties in the territory South of Bloomfield, and that he will be advertising to fill the common laborer position.

The Board met with Tom Prosapio for an update on the Courthouse Accessibility project. Tom reported that there is a list of detail finishing work being done to bring the project closer to completion.
