The Davis County Board of Supervisors met in regular session on Monday, July 15, 2024 with Chairman David Henderson and Members Alan Yahnke and Ron Bride present.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve the agenda.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, July 1, 2024.

The Board met with Engineer Ryan Schock, who reported 697 ton of rock was hauled last week and the areas of the County where mowing is being done. He also reported on the progress of the Dykes Bridge and both SIDCA projects were approved last week. Bids were sent out to contractors which are due back August 1, 2024.

The Board met with County Assessor Jason Wagler, who presented the 2024 Homestead Credit and Exemption applications, the Disabled Veteran Homestead Credit applications and the Military Credit applications.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to disallow 1 (one) Military Credit Application and to approve all other Homestead Credit and Exemption applications, Disabled Veteran Homestead applications and Military Credit applications per the recommendation of County Assessor, Jason Wagler.
