The Davis County Board of Supervisors met in regular session on Monday, September 16, 2024 with Chairman David Henderson and Members Alan Yahnke and Ron Bride present.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve and sign the Minutes of Monday, September 9, 2024.

The Board met with Engineer Ryan Schock, who reported on mowing, blading, rock hauling and ditching projects being undertaken by the County crews.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to approve and award the contract (bids being opened at last board meeting) with Iowa Bridge and Culvert for the Shale Avenue Bridge, in the amount of \$282,478.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve naming Zach Musgrove as a Davis County Medical Examiner Investigator.

Following a brief discussion, Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to make the County document titled "Personnel Policies for Bargaining Unit Employees", dated February 23, 2018, null and void, effective immediately. All employees, including the bargaining unit employees, should refer to the document titled "Davis County Employee Information Handbook", dated February 20, 2018, from this point forward.

At 10:00 a.m., Ron Bride made motion, seconded by Alan Yahnke and by roll call vote, carried unanimously, to go into closed session to discuss strategy with Attorney Brent Hinders, regarding matters that are presently in litigation where its disclosure would be likely to prejudice or disadvantage the position of the governmental body in that litigation, pursuant to Iowa Code Section 21.5(1)(c). After discussion, Ron Bride made motion, seconded by Alan Yahnke to leave the closed session and return to the open meeting.

Thereafter, Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the settlement release (Case No. LALA012758) and have ICAP (Iowa Communities Assurance Pool) pay the sum amount indicated in the agreement.
