The Davis County Board of Supervisors met in regular session on Monday, November 18, 2024 with Chairman David Henderson and Members Alan Yahnke and Ron Bride present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Tuesday, November 12, 2024.

The Board met with Engineer Ryan Schock, who discussed the blading, rock hauling and ditching work being done by the County crews. He reported 1,818 ton of rock was hauled last week.

Dave Henderson opened the public hearing regarding the road vacation for a portion of 305<sup>th</sup> Street. There were no public written or verbal comments. Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to close the public hearing.
