The Davis County Board of Supervisors met in regular session on Monday, November 25, 2024 with Chairman David Henderson and Member Ron Bride present. Member Alan Yahnke was absent.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Dave Henderson and carried unanimously, to approve and sign the Minutes of Monday, November 18, 2024.

The Board met with John Schroeder regarding the Davis County Development Corporation office at 203 S. Madison Street. He submitted an invoice for window blinds to be approved at the next meeting.

The Board met with Engineer Ryan Schock, who reported on the blading, dozing, patching, rock hauling and ditching work being done by the County crews.

Ron Bride made motion, seconded by Dave Henderson and carried unanimously, to sign the resolution to award the contract for Monterey paving project (106) to Cedar Valley Corp LLC \$1,923,730.37 and to approve the County Engineer to sign the contract in DocExpress.

The Board reviewed the letter, with Assistant County Attorney Ashley Walkup, regarding the possibility of a nuisance ordinance being created in response to a citizen complaint.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to approve sending the letter as presented.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the Special Class C Retail Alcohol License for the Davis County Agricultural Society (Davis County Fair) covering 2025 year of events.

The Board discussed and reviewed options for yard equipment for the Courthouse and possible purchase. No action was taken.

The Board met with Megan Clyman who presented an update for IT coverage of the HVAC System at the Davis County Home. She made a recommendation to pay CMTEL for Wi-Fi coverage if the building is not occupied in order to keep the system running properly and to be able to access it remotely.

The Board held a discussion regarding the sale of the Davis County Home. No action taken.
