The Davis County Board of Supervisors met in regular session on Monday, January 13, 2025, with Chairman Alan Yahnke and Members Ron Bride and David Henderson present.

Ron Bride made motion, seconded by David Henderson and carried unanimously to approve the agenda.

David Henderson made motion, seconded by Ron Bride and carried unanimously to approve and sign the Minutes of Monday, January 6, 2025.

The Board met with County Engineer Ryan Schock, who reported on the blading, rock hauling and brush cutting work being done by the County crews.

Ron Bride made motion, seconded by David Henderson and carried unanimously to approve and sign the Resolution to close and vacate Overland Avenue.

David Henderson made motion, seconded by Ron Bride and carried unanimously to authorize the Davis County Auditor to pay, without prior approval, any freight, postage, water, lights, telephone, and contractual services; salaries and payrolls previously fixed by the Board.

Ron Bride made motion, seconded by David Henderson and carried unanimously to not pay expenses for national meetings without prior approval from this day forward.

After much discussion and upon the recommendation of County Attorney Rick Lynch, David Henderson made motion, seconded by Ron Bride and carried unanimously to pay retiring Sheriff Dave Davis, whose term ended at 11:59 p.m. on January 1, 2025, salary for one day in January, 2025 and the County's portion of coverage for health, dental and life insurance for the month of January.

The Board held a discussion regarding the sale of the Davis County Home. No action taken.
