The Davis County Board of Supervisors met in regular session on Monday, February 10, 2025 with Chairman Alan Yahnke and Members Ron Bride and David Henderson present.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by David Henderson and carried unanimously, to approve and sign the Minutes of Monday, February 3, 2025.

The Board met with Engineer Ryan Schock, who reported on the blading, sand and rock hauling and equipment repair work being done by the County crews.

There was discussion with Engineer Schock and the Board regarding the draft letter of guidelines for other County organizations that use Secondary Roads' equipment. The Board asked for more time to review said letter with the County Attorney and no action was taken.

Ron Bride made motion, seconded by David Henderson and carried unanimously, to approve the resolution to set the letting date of April 21, 2025 for the Farm-to-Market Rock Program.

The Board met with Sheriff Zachary Dunlavy who reported on upcoming staffing changes that will result in a Sheriff's Deputy position opening in mid-April. Sheriff Dunlavy informed the Board that since it is required that the opening be posted for 30 days, he intends to advertise it now to avoid a staff shortage in April. No action was taken.

The Board discussed the necessity to have all the utilities at the County Home changed over to the County due to former Tenant Optima vacating the property on January 31, 2025 and directed Auditor Kristi Goodson to complete the applications necessary for said transfers.

All Board members reported on committee meetings attended.

The Board met with County Auditor Kristi Goodson to review departmental budgets.
