The Davis County Board of Supervisors met in regular session on Tuesday, February 18, 2025, with Chairman Alan Yahnke and Members Ron Bride and David Henderson present.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by David Henderson and carried unanimously, to approve and sign the Minutes of Monday, February 10, 2025.

The Board met with Engineer Ryan Schock, who reported on the blading, sand and rock hauling and equipment repair work being done by the County crews. Engineer Schock also reported that letters have been mailed to two citizens regarding the removal of their personal property from the County right-of-way.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the Baird Bros Paint bid of \$3,810.00 to repaint the parallel parking spaces around the perimeter of the Court yard upon completion of City of Bloomfield's project to resurface the city square streets.

The Board met with Assistant County Attorney, Ashley Leyda-Walkup, regarding the pending County Farm Lease Agreement. After discussion regarding minor changes, David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve advertising the bidding procedure with the Bloomfield Democrat and the Tri-County Shopper and to prepare packets for bidders.

Assistant County Attorney, Leyda-Walkup also presented the Board with a preliminary Plat of Survey showing progress of the survey work being done by Garden and Associates at the site of the County Home to determine boundary lines for the piece of property to be sold and the piece containing farm ground being retained by the County. No action was taken.

All Board members reported on committee meetings attended.
