The Davis County Board of Supervisors met in regular session on Monday, March 10, 2025 with Chairman Alan Yahnke and Members Ron Bride and David Henderson present.

Ron Bride made motion, seconded by David Henderson and carried unanimously, to approve the agenda.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, March 3, 2025.

The Board met with Engineer Ryan Schock, who reported on the blading, rock hauling and brush cutting work being done by the County crews.

After a brief discussion, David Henderson made motion, seconded by Ron Bride and carried unanimously to sign their approval to a 28E Agreement between Davis, Appanoose and Wayne Counties setting out details and terms of shared portable traffic signals.

No action was taken on the policy letter regarding outside county organizations' use of Secondary Roads' equipment.

After consideration, David Henderson made motion, seconded by Ron Bride and carried unanimously to approve Servpro's bid of \$14,073.44 for cleanup of water damage resulting from a broken water line. Said payment is subject to approval of a pending claim for damages with Iowa Communities Assurance Pool (ICAP), the County's liability insurance carrier.

The discussion regarding approval of requesting bid proposals to auction the County Home property was cancelled.

At 10:00 a.m. bids were opened for the County Farm Lease. High bid was received by David Boas at \$144.06 per acre. David Henderson made motion, seconded by Ron Bride and carried unanimously to sign a lease in accord with that bid.

All Board members reported on committee meetings attended.

Sheriff Zach Dunlavy reported there are currently 11 inmates in the jail. He also reported on progress being made on various maintenance-related issues at the Law Center.
